**Re: Pre-school Places for 2-year-olds at Cromwell Academy**

Thank you for your interest in the Pre-school at Cromwell Academy for your child. We offer free part-time place (15 hours per week) or a free full-time place (30 hours per week). Please see the information below to find out more about free pre-school hours under the government early years schemes.

**1. Free education and childcare for 2-year-olds if you claim certain benefits**

A two year old is eligible for a free part-time (15-hours) early education place from the term after their second birthday if you live in England and get any of the following benefits:

- Income Support
- income-based Jobseeker's Allowance (JSA)
- income-related Employment and Support Allowance (ESA)
- Universal Credit, and your household income is £15,400 a year or less after tax, not including benefit payments and the guaranteed element of Pension Credit
- Child Tax Credit, Working Tax Credit (or both), and your household income is £16,190 a year or less before tax the Working Tax Credit 4-week run on (the payment you get when you stop qualifying for Working Tax Credit)

OR

- has been adopted from local authority care
- has been looked after by a local authority
- has left care through a special guardianship or child arrangements order
- is in receipt of Disability Living Allowance
- has an Education, Health and Care (EHC) Plan

**2. Government working parents' scheme**

If you meet certain criteria, you may be eligible for full funding of up to 30 hours a week, for working parents this is known as **extended entitlement**. To be eligible for the extended entitlement, both parents must be earning, or expect to earn, the equivalent of 16 hours at National Minimum or Living Wage, up to a maximum of

If you meet the criteria for a full-time place for your child, HMRC will give you an eligibility reference number (eligibility code). **You will need to give this number to the school office so that we can complete the application on your behalf.**

If you are not eligible for the extended entitlement, you will still qualify for 15 free hours of funding (half-day, each day). If you book sessions totalling more than 15 hours you will have to pay for these non-funded sessions. We offer sessions as detailed below:

Morning sessions: 8.40 am to 11.40 pm (15 hours per week)

Afternoon sessions: 12.10 pm to 3:10 pm (15 hours per week)

There will be a limited amount of 2.5 day places (15 hours per week): Monday 8.40am to 2.40pm, Tuesday 8.40am to 2.40pm, and Wednesday Morning or Wednesday afternoon, Thursday 8.40am to 2.40pm, and Friday 8.40am to 2.40pm.

Full day: 8.40am to 2.40pm (this fulfils the 30 hour entitlement but parents do have the option to top up their child's hours by 30 minutes per day to 3.10pm for an additional charge of £4.22 per day)

### 3. **Key Dates:**

We have three intakes for Pre-school: September, January and April. Children are eligible to start in the term after their second birthday. Registration for pre-school place must be made a term in advance. For example, if your child is eligible for funding in January 2027 you will need to apply for your child's place in September 2026.
